Official Rules for the Win a Tablet Sweepstakes

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. **Eligibility**: The Win a Tablet Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are at least eighteen (18) years of age. - 12. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the Commonwealth of Massachusetts.
